2019 International Fees Schedule

Senior Fees (Years 5 to 12)

Tuition (\$AUD)	\$ 7,290 per term \$29,160 per year
Boarding (\$AUD)	\$ 5,715 per term \$22,860 per year

Boarding is invoiced as two components each term:

- a) Accommodation \$4,145 per term (GST free)
- b) Meals \$1,570 per term (incl. GST)

To confirm enrolment, the following fees are required to be paid for students in Years 5 to 12:

Boarding fees (for two terms)	\$ 11,430
Deposit (refunded upon completion of study)	\$ 4,000
Capital fee (one off payment)	\$ 1,200
Weekend activities (per annum) (incl. GST)	\$ 500

Boarding for international students is available from Year 6.

Other Costs

Additional optional activities may include: Outdoor Education camps, private Music, Art or Sport lessons.

Year 9 ASPIRE trips attract additional costs dependent on options selected (refer to Handbook).

A Rowing Levy applies to students involved in the Rowing Program.

Overseas Student Health Cover

The cost of Overseas Student Health Cover is determined by the duration of the student visa and must be paid in full at the time of enrolment. Current fees for the first enrolment year are approximately \$AUD544.

Terms and Conditions

Terms and conditions apply to payment of school fees and are provided in full on application. All fees are subject to change each year as specified by the School Board. Fees quoted herein are current fees only.

After the initial payment, the tuition and boarding fees will be due each term plus any other incidental items such as private tuition, sundry boarding expenses (pharmacy, taxi charges, etc).

Invoices are sent before the beginning of each term and are payable within 30 days. One full school term's notice in writing must be provided to the Principal if a student is withdrawing from the School. If one full school term's notice in writing is not received then one term's tuition fees are charged in lieu of this notice. This is a strictly enforced policy and necessary to ensure class planning and to ascertain available places for future students applying for enrolment.

The Boarding fee includes holiday accommodation for two weeks in April and September.

Notebooks

Notebook computers are compulsory for all Middle School students (Years 5 to 8). Collegiate has negotiated special pricing and specifications for the approved 2019 device, the Lenovo Thinkpad Yoga 11E Gen 5. Senior School students participate in our Bring Your Own Device (BYOD) program. Details regarding both the Middle School approved device and Senior School BYOD are available on our website.
